### Foundation Statement

EREA seeks to respond to the needs of young people disenfranchised and disengaged from education through the provision of a safe place that provides an opportunity for them to re-engage in a suitable, flexible learning environment.

Flexible Learning Centres seek to build honest and authentic relationships with young people, their families and communities, through valuing, supporting and celebrating the uniqueness and dignity of each person.

EREA Flexible Learning Centres are guided by the vision of Edmund Rice, and the empowering service of education, so that young people may achieve personal and community liberation through educational experiences that enable transformation.

### Background

Flexible Learning Centres (FLCs) are an initiative of Edmund Rice Education Australia (EREA) offering a full-time and multiyear secondary education and social inclusion program for young people who have disengaged from mainstream structures. Young people may express a broad range of complex education and social needs and the FLC services respond with a variety of flexible and innovative social inclusion and learning experiences.

FLC services provide young people with a varied and holistic set of learning experiences, supporting them to identify and pursue an individual transition to adulthood, employment, further education and training, and social connectedness.

Indigenous and non-indigenous young people who attend are usually disengaged from mainstream education for a range of reasons that may include those:

- who have had contact with the juvenile justice system;
- in the care of the Office of Children and Families;
- with a history of trauma;
- with a history of extended periods of unexplained absences;
- who are highly mobile;
- with mental illness or at risk of engaging in self-harming behaviours or substance abuse;

- who have been excluded or repeatedly suspended from school;
- who are homeless;
- who are young parents;
- with a generational history of early school leaving; and/ or
- with a generational history of unemployment.

## Principles of Operation

The four principles of operation that all Flexible Learning Centres operate under are Respect, Participation, Safe and Legal and Honesty.

This framework is a significant point of difference from mainstream schooling. The principles establish a “common ground” among staff, young people and families where the means to resolve conflict, negotiate learning, recognise rights and responsibilities are modelled and explored, both within the group and individually.

A primary responsibility for this role is to maintain fidelity to Operation by Principle and the best practice guidelines as articulated in the Youth+ Foundation and FLC Occasional Papers (available on the website at <https://www.ereafsn.edu.au/wp-content/uploads/2017/09/18.-EREA-Youth-Foundation-Statement-Copy.pdf>).

## EREA Charter and Touchstones

Edmund Rice schools strive to offer a liberating education, based on a gospel spirituality, within an inclusive community committed to justice and solidarity. The Charter describes our distinct identity as Edmund Rice schools and provides a practical expression of this identity. The Charter uses four touchstones to describe the culture of a Catholic school in the Edmund Rice tradition. These touchstones give us ideals authentically linked with the Charism which underpins the ministry in our schools and educational endeavours. They help us set our direction and define our goals as, following Edmund Rice’s vision, we continue to reflect and to seek to make the Gospel a living reality in our communities. ## Primary Role

Based at the West Moonah Campus of St Francis Flexible Learning Centre and reporting to the Director Curriculum the primary objective of this role is to ensure the effective and co-ordinated delivery of a high-quality art program to all young people enrolled in the school. Key aspects of the role include:

1. Planning, preparation and delivery of effective art programs for young people
2. Help students grow in their enjoyment, appreciation, and creation of art through a variety of planned experiences.
3. Contributing to the development and implementation of the Flexible Learning Centre’s objectives and planning.
4. Contributing to the establishment and maintenance of a supportive school environment.

## Duties and Responsibilities

Typical duties and responsibilities include but are not restricted to:

1. Maintain fidelity to and model best practice in Operation by Principles and other key EREA practices as articulated in our Framework;
2. In collaboration with other teachers and youth workers, plan and implement an art program that engages young people and offers a range of art focussed learning choices including:
  - Integrated and applied learning;
  - Accredited learning opportunities; and
  - Development of individual learning plans in collaboration with young people and youth workers
3. Demonstrate and assist students to use different techniques and media to develop art works aligned to



their artistic abilities

4. Inform students about cultural and historical influences on art
5. Provide instruction that encourages students to understand and appreciate art
6. Encourage students to express their own personalities and thoughts through the creative process
7. Participate in program provision to ensure wellbeing in an inclusive learning environment
  - Maintain fidelity to, and role model, Operation by Principles and the best practice guidelines as articulated in the EREA Practice Framework.
  - Collaborate with the team to support a socially inclusive music program that responds to the physical, intellectual, social, spiritual and cultural needs of young people.
  - Work collaboratively with the team to support/develop cultural links, community and family connections which support the engagement and connection of young people to learning and the wider community.
  - Participate in the daily routines and activities of the FLC e.g. morning meetings, lunch, bus pick up and drop offs, electives, outings, camps.
8. Team participation/multidisciplinary practice
  - Participate in professional supervision.
  - Participate in daily and weekly staff meetings, and whole team reflective practice sessions
  - Operate within the context of EREA Policies and Procedures.
  - Participate in professional development that is relevant to the work of the FLC.
9. Administrative Responsibilities
  - Maintain appropriate records and prepare reports as required.
  - Maintain student database (i.e., student attendance roles).
  - Contribute to the development of personal learning plans.
10. Carry out duties and tasks that may be reasonably assigned by the Principal or Deputy Principal from time to time.
11. All staff are expected to implement self-care strategies, and access organisational staff supports wherever needed.
12. **Support and comply with Child Safeguarding Practices according to policy**
  - Abide by EREA's [Child Protection Policies](#), [Code of Conduct](#), and [Child Safe Code of Conduct](#).
  - Abide by EREA's [Child Safety Policy and Code of Conduct](#).
  - In consultation with the Principal, Deputy Principal or School Leader/s provide support to young people and families dealing with issues of child safety.
  - Ensure legal and mandatory reporting obligations are met, consistent with the FLC's 'Procedures for Responding to and Reporting Allegations of Child Abuse' within the FLC's 'Child Protection Program'.
  - Provide a referral point for young people and families to appropriate support services.
13. Other duties as reasonably directed by the Principal or Deputy Principal
14. Ensure that all Safety /OHS and general school procedures and protocols are followed
